The **GINA'S GARDEN RESORT**, a resort with swimming pool located at Brgy. Bical Norte, Bayambang, Pangasinan owned by **GINA DE VERA** herein referred to as the **SECOND PARTY**.

#### WITNESSETH

WHEREAS, the FIRST PARTY has offered a new program – the Bachelor of Physical Education (BPED) under CMO 80 s.2017 which was duly approved by the Commission on Higher Education;

WHEREAS, one of the objectives of the program is to train students to become innovative, holistic, and world class BPED professionals through actual exposure to a physical fitness workplace environment;

WHEREAS, the FIRST PARTY has chosen the SECOND PARTY as one of the former's venues for practicum purposes given the latter's extensive resources and its proximity;

WHEREAS, the FIRST PARTY shall provide the SECOND PARTY with the current guidelines on the practicum training, the list of names of the participating BPED students, the nature of educational assignments of each student, the dates when the students are to report for their assigned tasks and the total number of training hours, required under the program;

WHEREAS, the PSU and GINA'S GARDEN RESORT, hereinafter collectively referred to as "PARTIES", undertake to collaborate toward the successful implementation of the course for quality education;

WHEREAS, PSU with its goal of implementing its CMO Mandate enters into an agreement to use the swimming pool of Gina's Garden Resort for the BPED students.

**NOW, THEREFORE,** for and in consideration of the foregoing premises, the PARTIES hereby agree the following conditions:

# THAT, the FIRST PARTY shall :

- 1. Provide the list of students and their schedule of training within the semester;
- 2. Assign faculty member who will assist in the scheduled training of the BPED students;
- 3. Provide orientation to their students on the guidelines that should be strictly followed during the training;
- 4. Monitor the training of the students as stipulated in the training schedule; and
- 5. Conduct evaluate on the training progress of their students.

## That the SECOND PARTY shall:

- 1. Conduct in-house orientation regrading the rules and regulations;
- 2. Assist on the needs of the students during the training;
- 3. Collect P90.00 for the entrance fee per student and P150.00 per cottage only during the scheduled training;
- 4. Provide feedback on the implementation of the training program; and
- 5. Maintain good rapport with PSU through their students and faculty.

Amendments and modification of this MOA should be done and agreed upon by both parties.

This agreement shall become effective on February 22, 2021 and shall remain in full force and effect within five (5) years unless both parties here concerned shall agree to terminate the same.

The MUNICIPAL PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL under the management of Mayor CEZAR T. QUIAMBAO herein referred as the "SECOND PARTY".

#### WITNESSETH:

WHEREAS, the FIRST PARTY has offered a new program – he Bachelor of Physical Education (BPED) under CMO 80 s.2017 which was duly approved by the Commission on Higher Education;

WHEREAS, one of the objective of the program is to train students to become innovative, holistic, and world class BPED professional through actual exposure to a physical fitness workplace environment;

WHEREAS, the FIRST PARTY has chosen SECONDARY PARTY as one of the former's venues for the practicum purpose given the latter's extensive resources and proximity;

- 1. The **FIRST PARTY** shall provide the **SECOND PARTY** with the current guidelines on the Practicum training;

WHEREAS, the SECONDARYPARTY agreed to cooperate with the FIRST PARTY in the utilization of the former's premises and facilities as an extension for educational training;

**WHEREAS**, the PSU and the LGU, hereinafter collectively referred to as "BARTIES", undertake to collaborate toward the successful implementation of the course for the quality education.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the PARTIES hereby agree to the following terms and conditions:

THAT, the **FIRST PARTY** shall instruct the BPED faculty and students to:

- 1. Take care the equipment after use;
- 2. Observe discipline, cleanliness, and wear proper attire inside the facility;
- 3. Follow strictly the rules and regulations of the Gym; and
- 4. BPED faculty in-charge must look into the safety of the students before, during, and after the class.



### THAT, the SECONDARY PARTY shall:

- 1. Accommodate the students and the faculty upon entering the Gym;
- 2. Strictly implement the general rules and regulations of the Gym; and
- 3. Report any misconduct of any students to the faculty in-charge.

Amendments and modification of this MOU should be done and agreed upon by both parties.

This Understanding shall become effective on February 22, 2021 and shall remain full force and effect within five (5) years unless both parties here concerned shall agree to terminate the same.
